

## ADMISSION RULES FOR FOREIGN CITIZENS AND STATELESS PEOPLE TO RYAZAN STATE MEDICAL UNIVERSITY IN 2026

155. Foreign citizens and stateless persons have the right to study on the basic educational programs of higher professional education at the expense of budget allocations in accordance with international agreements of the Russian Federation, Federal Laws or within the quota on education of foreign citizens and stateless persons, stated by the Government of the Russian Federation (hereinafter the quota on education of foreign citizens) as well as on the basis of contracts for rendering of fee-paying educational services with a legal entity or a natural person.

156. Admission of foreign citizens within the educational quota for foreign citizens is conducted by the federal executive body realizing functions of formulation of State policy and legal and regulatory framework in the educational sphere. Enrolment of the foreign citizens within the quota on education of foreign citizens is completed with a separate order (orders) of the organization.

157. Foreign citizens applying on the basis of international agreements provide the documents proving their right to apply on the basis of these agreements besides the documents mentioned in the Article 77 of the present admission rules.

158. Foreign citizens and stateless people being compatriots residing abroad (hereinafter compatriots) should provide the originals or copies of the documents mentioned in by Article 17 of the Federal Law № 99-FL dated May 24, 1999 “Concerning the state policy of the Russian Federation in regard to compatriots residing abroad” besides the documents, mentioned in the Article 76 of the current admission rules.

159. Specific rules of admission to the educational programs of higher education - bachelor, specialist programs provided in accordance with the Federal Law № 273-FL, except for the specific rule of admission provided in accordance with Paragraph 1 of Part 4 of Article 71 of the Federal Law №273-FL, are not spread on compatriots residing abroad who are not citizens of the Russian Federation unless authorized by an international agreement of the Russian Federation.

160. In accordance with the point 1 of Article 77 of the present Rules, a foreign citizen or a stateless person should provide an original or a copy of the document proving citizenship and identity of the foreign citizen in the Russian Federation as mentioned in Article 10 of the Federal Law № 115-FL dated July 25, 2002 “Concerning the legal status of the foreign citizens in the Russian Federation”.

161. Admission of the foreign citizens and stateless people at the educational programs connected with the official secret is carried within admission quota for the foreign citizens in accordance with the requirements set up by the official secret legislation acts of the Russian Federation.

162. Under admission of the foreign citizens and stateless people to the educational programs of higher education - bachelor, specialist programs on the basis of contracts for rendering of fee-paying educational services the University sets the list of entrance examinations (hereinafter entrance examinations for foreign citizens):

The entrance examination in Russian for foreign citizens is included in the list of entrance examinations for foreign citizens in case if programs of higher education - specialist programs are realizing in Russian from the first year.

The University considers the certificate of passing the test in Russian as in foreign language issued in accordance with the Procedure of issuing of the certificate of passing the test in Russian as in foreign language and proving Russian language proficiency as a foreign language on the first level or higher as the result of the entrance examination in Russian. The University sets the accounting for the certificate in accordance with the Procedure for entrance examination.

163. The entrance exams are conducted in a full-time format, but the university may also offer remote testing options (at the applicant's request). Applicants will need to be identified when they complete the entrance test, in accordance with paragraph 42 of the Admissions Rules.

The University sets number of seats for education on the basis of contracts for rendering of fee-paying educational services for foreign citizens and stateless people itself and holds contest on these seats.

164. The foreign citizens and stateless people can choose to hold the entrance examinations set for the foreign citizens or the entrance examinations mentioned in articles 22, 28-33 of the present Admission Rules.

165. Under admission of the foreign citizens and stateless people to the educational programs of higher education - master programs on the basis of contracts for rendering of fee-paying educational services the University organizes the following examinations as it is stated in the Article 14 of the Admission Rules:

32.04.01 Public Health – Public Health exam;

33.04.01 Industrial Pharmacy – Economics.

166. The admission period for foreign citizens, applying to study on the basis of contracts for rendering of fee-paying educational services is:

1) starting date for the acceptance of documents required for admission to the University – June 20, 2026;

finishing date for the acceptance of documents required for admission to the University for citizens of foreign countries entering the University on the basis of the results of the entrance examinations organized by the University independently – July 10, 2026;

2) finishing date of the entrance examinations organized by the University independently – July 25, 2026;

3) date of enrolment is August 12, 2026.

In case there are vacant places for enrolment after August 12th, 2026, the University holds additional enrolment before September 30th 2026.
